Privacy Policy in accordance with articles 13-14 of Regulation (EU) 2016/679

Data Subjects: visitors to the Website.

Gi.Max Srl, in its capacity as Data Controller in relation to your personal data, in accordance with and for the purposes of Regulation (EU) 2016/679, hereinafter 'GDPR', hereby informs you that the aforementioned regulation is designed to protect data subjects as regards personal data processing, and that such processing will comply with the principles of fairness, lawfulness and transparency, protection of your confidentiality and your rights.

Retention Period. Please note that, in accordance with the principles of lawfulness, purpose limitation and data minimisation under art. 5 of the GDPR, the retention period for your personal data:

- will not exceed the period required to achieve the purposes for which they were collected and processed and complies with mandatory terms set out by law.

Regulation (EU) 2016/679: Articles 15, 16, 17, 18, 19, 20, 21 and 22 - Rights of the Data Subject

1. The data subject has the right to obtain confirmation as to whether or not personal data concerning him or her exists, even if they have not yet been recorded, and to receive such in intelligible form, and has the option to submit a complaint to the Supervisory Authority.

2. The data subject has the right to be told:

- a. the source of the personal data;
- b. the purposes and methods of its processing;
- c. the logic applied in the case of processing involving electronic tools;
- d. the identity of the controller, processors and designated representative in accordance with article 5, paragraph 2;
- e. the parties or categories of parties to whom the personal data may be disclosed or who may gain access to them in their capacity as designated representative within the State, processors or appointed persons.

3. The data subject has the right to obtain:

- a. the updating, rectification or, if in his or her interest, completion of the data;
- b. erasure or anonymisation of the data, and to block data processed in breach of the law, including data that do not need to be retained for the purposes for which they were collected or subsequently processed;
- c. confirmation that the operations referred to in points a) and b), including their content, have been brought to the attention of the subjects whose data have been disclosed or distributed, except in cases where to do so would be impossible or would involve the use of resources disproportionate to the right to be protected;
- d. portability of the data.

4. The data subject has the right to object, in whole or in part:

- a. for legitimate reasons, to the processing of personal data concerning him or her, even if relevant to the purpose for which they were collected;
- b. to the processing of personal data concerning him or her for the purposes of sending advertising or direct sales material, carrying out market research or sending business communications.
